

Return/Exchange Policy

Brand new unused items purchased from J.G. Uniforms may be either exchanged or returned within 30 days of receipt. These items must be in their original condition including all merchandise tags and packaging. Uniform items with shoulder patches sewn will be eligible for return or exchange. Only pants that are hemmed in excess of a 30" inseam will be eligible for return or exchange. We will not accept returns of any items that are embroidered, silk screened or customized in any way.

Any order that was processed and delivered incorrectly due to our error, is eligible for a full refund or replacement.

We will make available to the Schaumburg Police Department, at no additional cost, a designated salesperson that can visit the department on a weekly basis to go over any returns/exchanges, take measurements or pick up new orders.

Delivery of all new orders will be made, at no additional cost, by our salesperson. Each delivery will be separated by the end user name and will have a packing list. It's imperative to verify that the packing list matches up with the items in the package. If there are any discrepancies, please call the office immediately.

Warranty Information

All of the items listed on the Bid Sheet carry an industry standard manufacturer's warranty against any defects. If you feel an item is defective, please contact us and we will reach out to the manufacturer to see if it qualifies for replacement. Specific warranties for each Brand are available upon request.
