1. Barb & Dan Reining, 351 Newgate

Ms. Mundstock reported she's been having issues with her next-door neighbor coming onto her property. Trustee Dunham asked that she speak to Ryan Franklin after the meeting to see what assistance Community Development could provide.

3. John Schofield, 919 Pinehurst

Mr. Schofield stated that due to the configuration of his home he opted to not take any garbage cans from LRS, as he has no storage. He was told by LRS staff that he needed to purchase smaller receptacles, as they didn't offer any smaller options. He also mentioned he left trash on his driveway in a bag and they didn't pick it up, he had to call and they came out the following day to pick it up. Director Hall confirmed that LRS is required to pick up all bagged refuse.

Mr. Schofield asked about removing parkway trees. Trustee Madej explained that even if a resident plants their own parkway tree, parkway trees cannot be removed by residents.
