## AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.03(G)(9) OF THE SCHAUMBURG VILLAGE CODE RELATIVE TO WAITING PERIOD REQUIREMENTS FOR VIDEO GAMING LICENSES

**WHEREAS**, the Village of Schaumburg, as a home rule unit of local government as provided by Article VII, Section 6 of the Illinois Constitution of 1970, has the authority to exercise any power and perform any function pertaining to its government and affairs except as limited by Article VII, Section 6 of the Illinois Constitution of 1970; and

**WHEREAS**, the Village previously enacted certain regulations to allow for video gaming pursuant to specific liquor licenses, along with a one-year waiting period for businesses to be eligible for a video gaming license; and

WHEREAS, the Village desires to remove the one year waiting period; and

**WHEREAS**, the President and Board of Trustees of the Village of Schaumburg have determined that amending the Village Code to reflect the same is in the best interest of the Village;

## NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF SCHAUMBURG:

**SECTION ONE:** The recitals above shall be and are hereby incorporated in this Section 1 as if restated herein.

**SECTION TWO:** Title 11, Chapter 112, Section 112.03(G)(9) of the Schaumburg Village Code is hereby amended to read in its entirety as follows:

- "(9) The establishment must be in good standing with the village. To be in "in good standing" the licensee shall:
  - (a) Owe no sums of money to the village at the time of its application;
  - (b) Have held, or otherwise be eligible to hold, a consumption on the premises liquor license;
  - (c) Have had no legal violations causing a suspension of any liquor or business license in the twelve (12) months prior to its application for the video gaming license;
  - (d) Be in compliance with all dram shop and video gaming laws, rules and regulations of the Village of Schaumburg and the State of Illinois."

**SECTION THREE:** That this Ordinance shall be in full force and effect, after passage, approval and publication as required by law.
