**ORDINANCE AUTHORIZING THE DISPOSAL OF SURPLUS PERSONAL PROPERTY
OWNED BY THE VILLAGE OF SCHAUMBURG**

WHEREAS, in the opinion of at least three-fourths of the corporate authorities of the Village of Schaumburg, it is no longer necessary, useful, or in the best interest of Schaumburg to retain ownership of the personal property hereinafter described; and

WHEREAS, it has been determined by the President and the Board of Trustees of the Village of Schaumburg that it is in the Village's best interest to dispose of said personal property.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF SCHAUMBURG:

SECTION ONE: Pursuant to Chapter 65, section 5/11-76-4 of the Illinois Compiled Statutes, the President and Board of Trustees for the Village of Schaumburg find that personal property listed below now owned by Schaumburg is no longer necessary or useful, and Schaumburg's interest would be best served by the properties' disposal.

SECTION TWO: The Village Manager for the Village of Schaumburg is hereby authorized to direct the disposal of the personal property detailed below either through approved live or on-line auctions or trade-in, with minimum values as set forth in the table below:

SECTION THREE: If auctioned, the Village Manager is hereby authorized to: direct the auctioning agency to advertise the sale of the aforementioned personal property through area newspapers, direct mailings, and other channels deemed appropriate prior to the date of the auction; direct the auctioning agency to enter into an agreement for the sale of said property whereby said property is sold at auction; and direct the auctioning agency, upon payment in full for the aforesaid items of personal property, to convey and transfer the title and ownership of said personal property to the bidder.

SECTION FOUR: No bid shall be accepted for the sale of an item which is less than the minimum value set forth herein, unless the Village Manager or the designee of the Village Manager so authorizes at the time of the auction or trade-in.

SECTION FIVE: This ordinance shall be in full force and effect from and after its passage, by a vote of at least three-fourths of the corporate authorities, and approval in the manner provided by law.
