Golf Road, Case No. Z2410-01 is desirable to provide a service or a facility, which is in the interest of public convenience, and is in the best interest of the Village.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF SCHAUMBURG:

SECTION ONE: That said Parking Variation and Valet Parking Plan Approval described as follows:

- Parking Variation to Reduce the Required Parking from 132 to 0 parking spaces [Title 15, Chapter 154, Section 154.123]
- Valet Parking Plan [Title 11, Chapter 129, Section 129.06]

for Fogo De Chao located at 1950 E. Golf Road, Case No. Z2410-01 be and is hereby granted on the property legally described as:

BEING A SUBDIVISION IN THE SOUTHEAST ¼ OF SECTION 12, TOWNSHIP 41, RANGE 10 EAST OF THE THIRD PRINCIPAL MERIDIAN, AND THE SOUTHWEST CORNER OF FRACTIONAL SECTION 7, TOWNSHIP 41 NORTH, RANGE 11 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

SECTION TWO: That the granting of the approvals and/or variations of Section One, be and is hereby granted subject to compliance with the following conditions:
