**A RESOLUTION AUTHORIZING PARTICIPATION IN THE ILLINOIS DEPARTMENT OF TRANSPORTATION'S ADVANCED TRAFFIC MANAGEMENT SYSTEM**

**WHEREAS**, the Transportation Committee of the Village of Schaumburg has recommended that the Village of Schaumburg participate in the Illinois Department of Transportation's Advanced Traffic Management System (ATMS); and

**WHEREAS**, the Illinois Department of Transportation, as part of the Federal Government's Congestion Mitigation and Air Quality Improvement Program (CMAQ), will improve the operation of existing signalized intersections within the Northwest Cook County area through the ATMS; and

**WHEREAS**, the Village Board previously granted approval at their meeting on December 13, 2022 for the Village President to execute a Letter of Intent for the ATMS; and

**WHEREAS**, it is in the best interest of the Village of Schaumburg to execute the Letter of Understanding with the Illinois Department of Transportation for Contract Number 62R81 for signal improvements at the intersections of Plum Grove Road and Woodfield Road, and Plum Grove Road and American Lane for the ATMS; and

**WHEREAS**, it is in the best interest of the Village of Schaumburg to execute the Agreement with the Illinois Department of Transportation for Contract Number 62T54 in the amount of \$465,500 for the Village's 100% cost for improvements related to the ATMS, including traffic signal equipment upgrades at thirteen (13) Village-owned traffic signal locations and installation of single mode fiber optic cable along Meacham Road between Algonquin Road (IL-62) and Higgins Road (IL-72); and

**WHEREAS**, it is in the best interest of the Village of Schaumburg to execute an Intergovernmental Agreement with the Illinois Department of Transportation for the ATMS; and

**WHEREAS**, the Transportation Committee, Transportation, Finance Departments and Legal have reviewed the Letter of Understanding for Contract 62R81 marked "Attachment A", the Agreement for Contract Number 62T54 marked as "Attachment B" and the Intergovernmental Agreement marked as "Attachment C" attached hereto.

**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF SCHAUMBURG:**

**SECTION ONE:** That the Village Manager be and hereby is authorized and directed to execute the attached Letter of Understanding, "Attachment A", between the Village of Schaumburg and the Illinois Department of Transportation.

**SECTION TWO:** That the Village Manager be and hereby is authorized and directed to execute the attached Agreement, "Attachment B", between the Village of Schaumburg and the Illinois Department of Transportation.

**SECTION THREE:** That the Village Manager be and hereby is authorized and directed to execute the attached Intergovernmental Agreement, "Attachment C", between the Village of Schaumburg and the Illinois Department of Transportation.

**SECTION FOUR:** This Resolution shall be in full force and effect from and after its passage and approval according to law.
