Trustee Dunham introduced the trustees and staff present.

1. Barbara and Don Reining, 351 Newgate Ct., Unit B2

Ms. Reining expressed her gratitude to the Village for the beautiful holiday decorations.

2. Bob Kaplan, 1421 Wyndham Cove Lane

Mr. Kaplan stated that he attended the meeting to wish everyone a Happy Holiday and thanked the staff for everything they do. He also mentioned his pleasure in seeing that the construction on East Schaumburg Road was completed.

3. Pat Riley, 128 Carryville Lane

Mr. Riley stated he was happy that the construction on East Schaumburg Road was completed. He noted that in the past, the road was difficult to navigate when heading toward Route 53.

4. Fred Wilson, 1006 Shannock Lane

Mr. Wilson expressed his satisfaction with the Village, stating that they were "doing a great job."

5. Robert Leesman, 1515 Syracuse Lane

Mr. Leesman asked if the Village had recommended an electric supplier, as they had done in the past. Mr. Madej stated they had not received preferred numbers that would make it worthwhile for the residents and added that he would stick with ComEd. Both Mr. Dunham and Mr. Madej suggested that if Mr. Leesman was considering solar, he should do his homework and investigate the companies before signing any contract. Mr. Madej mentioned that there were multiple Federal and State grants available for solar panels, and with proper research, significant funding could be obtained. Additionally, Mr. Clar stated that the Village had a Community Solar Program.

Mr. Madej suggested she download the phone app, which makes it easier to contact them and see the updates to her account. Ms. Sloan insisted on speaking to a person and asked how to do that. Mr. Dunham explained that she had to call them during business hours.

Ms. Sloan also inquired about the green transformers that she sees around town and in other municipalities. She mentioned observing wires hanging from these transformers and some that have been knocked over. Mr. Clar recommended she call the Village Manager's office, as they have liaisons with each utility company.
