CALL TO ORDER

- 3. Recommendation to amend the BFPC rules and regulations pertaining to oral interviews-Chairman Mazzeffi explained that statistical basis occurred during the promotional process due to the number of commissioners during the interviews for fire lieutenant. Due to this statistical bias, the Chairman suggests that the board has the same number of commissioners interviewing for each interview. Chairman Mazzeffi voiced his concern with the interviewing process for certified police candidates. Ms. Hewson suggests that the best practice in hiring is to establish a list, approve a list, and post it on the website. Mr. Mazzeffi asked Mr. Kelly if this is the best course of action. Mr. Kelly explained that the best practice is to follow the rules and regulations as outlined in the BFPC rules and regulations. Ms. Hewson agreed that is it best practice to always interview all candidates with the same commissioners. Ms. Pajak expressed her agreement that when conducting interviews all the same number of commissioners need to commit and agree to interview for the days of those interviews, to keep it best practice. Mr. Mazzeffi suggests that it is hard to commit to interviews in the future when they are unaware of their schedules. Ms. Hewson suggests approving amendments as suggested and taking a closer look at the certified candidates. Commissioner Peterson made a motion to approve the recommendations to amend the BFPC rules and regulations pertaining to oral interviews. Commissioner justen seconded the motion. Motion passes.
- 4. <u>Approval of Preliminary Fire Lieutenant Eligibility List-</u> A motion was made by Commissioner Peterson to approve the Fire Lieutenant Eligibility list, seconded by commissioner Pajak. No commissioners voted nay. MOTION CARRIED.
- 5. <u>Approval of 2023 Fire Lieutenant Eligibility List-</u> A motion was made by Commissioner Pajak to approve the Fire Lieutenant Eligibility list, seconded by commissioner Justen. No commissioners voted nay. MOTION CARRIED.
- 6. <u>Approval of Police Sergeant Promotional Eligibility List-</u> A motion was made by Commissioner Peterson to approve the Police sergeant promotional list, seconded by commissioner Justen. No commissioners voted nay. MOTION CARRIED.
- 7. <u>Approval of Entry level police officer eligibility List-</u> A motion was made by Commissioner Peterson to approve the entry level police officer eligibility list, seconded by commissioner Justen. No commissioners voted nay. MOTION CARRIED.

Mr. Mazzeffi asked for the department preparing the agenda for the appointment ceremonies to add a section for commissioners comments during the ceremony. He suggested this to ensure all commissioners were afforded the opportunities to say a few words.

Mr. Peterson presented his findings from the board of fire and police commissioners conference. He presented the evidence about the employment of non-us citizens as municipal police officers.

COUNSEL REPORT:

Mr. Kelly highlighted that the statue states that individuals from the DOCA program are approaching the age of hire for a police officer. He then highlighted that the police officer requirements are still to be enforced, and all candidates need to meet those requirements. He advises the commission to continue to follow the rules and regulations as stated in the BFPC rules. These rules include the ability to possess a firearm, which a status of citizenship is needed for that rule. Mr. Mazzeffi inquired about our rules including citizenship. Mr. Kelly said that they do.

This is a bit dependent on how you want this done. If you are satisfied with the current process and want 2-4 neighbors contacted via email/phone as references, your price would increase to \$1,900.00 per candidate (a rate increase of \$150.00).

If you want to have an investigator on the ground walking door to door that would increase your price dramatically. I would estimate \$2,500.00 per candidate plus any per diem incurred by the investigator.

Most agencies have had a lot of success just asking us to expand the current virtual / remote process (first quote), having us reach out to neighbors, etc.
