1. Discussion on potential Sister City relationship with Indore, India

The subcommittee discussed the steps to be taken in considering a proposal presented to the
Sister Cities commission to establish a sister cities partnership with Indore, India. The
subcommittee acknowledged Indore's designation as the cleanest city in India for seven
consecutive years, citing a mutual objective with Schaumburg in employing green initiatives.
Vandana Jhingan noted that Indore is a centrally located city that is easily accessible with its
own international airport. The subcommittee reviewed Sister Cities International's
community pairing survey, agreeing that survey modifications were needed to better
determine sister city compatibility between the two municipalities. The subcommittee will set
up a shared document to create a new paring survey for both cities.
